

Terms and Conditions

1. Enrolment

- Participants / parents / legal guardian should read the terms and conditions before submitting the enrolment form and settling the payment, if any. Plan International Hong Kong will refer to the part titled Program Name on the enrolment form as final.
- Participants / parents / legal guardians should submit the enrolment form on or before the closing date. Late applications will not be considered.
- Participants / parents / legal guardian should provide accurate Chinese and English name, contact number and e-mail on the enrolment form, so that Plan International Hong Kong can contact the relevant parties when necessary.

2. Eligibility

- The promotion runs from 20 November 2018 to 20 January 2019, both days inclusive. The promotion is eligible for new donors who sign up for “Kids Sponsor Kids – Child Sponsorship Programme” via Plan International Hong Kong’s website or referrers (or their child) who recommend their family and friends to join the “Kids Sponsor Kids – Child Sponsorship Programme”. To be eligible to participate in the promotion as referrer, he/she must be a Plan International Hong Kong’s existing Child Sponsor.
- Participants (or their parents) must remain as Plan International Hong Kong’s Child Sponsors when joining the activities/ workshops. Termination of sponsorship before activities/ workshops commence will result in forfeiture of the participants’ eligibility to join the activities/ workshops.

3. Payment Method

- The enrolment shall be completed via the online form provided by Plan International Hong Kong.
- Activities / workshops are only confirmed once fees are paid in full, if any.
- Applications are processed on a first-come-first-served basis upon full payment, if any. Acceptance is subject to the discretion of Plan International Hong Kong.
- The successful applicants will be notified of their application result via email. Please check your email accordingly.

4. No Refund

No refunds on activity/workshop fees paid, if any, will be made (including absenteeism or unable to provide related document proof on workshop date, etc.) except in the circumstances when an activity/workshop is full or being cancelled. Participants will be notified for such cases.

5. Non Transferable

Fees and places of the activities/workshops cannot be transferred. Only enrolled participants are allowed to attend the activity/ workshops.

6. No Exchange

The activity/ workshop's enrolment cannot be exchanged for cash or other gifts.

7. Points to Note

- Participants will be accompanied by his/ her parent/ legal guardian (1 Adult) in the *Mini Hunger Banquet*, *Parent-child Cooking DIY Workshop* and *"Experience Poverty" MapKing Orienteering Obstacle Race*. As for *"Love and Caring" Drama and Singing Workshop*, only participants will join the activity.
- BeConfident Alliance (the organiser of the activities/ workshops) may require participants to provide their identity certificates for verification. BeConfident Alliance reserves the right to stop those who fail to prove their identities from taking workshops.
- The workshop description is for reference only.
- BeConfident Alliance reserves the right to cancel the activity/ workshops if the number of application falls below the requisite minimum; and to change the time and instructor of workshops should this be necessary.
- No photo taking and video/audio recording is allowed by parents/ legal guardian/participant during class/workshop without the consent of BeConfident Alliance.
- Plan International Hong Kong and BeConfident Alliance are entitled to take photographs of, video-tape or audio-record the activities/workshops, and use such photo(s), image(s), audio(s) and video(s) ("Recordings") in any media or format throughout the world in perpetuity (including but not limited to press releases, print advertisements, posters, leaflets, Facebook page or other social networking sites or web pages for public viewing and

downloading, etc.) without any payment or consideration to the participants. The Recordings belongs to and is the absolute property of Plan International Hong Kong and BeConfident Alliance.

8. General

- Plan International Hong Kong has the absolute right to interpret these terms and conditions. In case of any disputes, the decision of Plan International Hong Kong shall be final and binding on all parties concerned.
